 HOA plans to increase membership. Another important topic will be our loss of
 income (approximately \$2,500) now the HOA has taken over the 2 USTA events. They
 will stress that IOTC that provides the volunteer staff that work these events and our
 need for "financial parity." Greg again brought up the possibility of a \$10 IOTC
 membership fee. After discussion the board was in agreement that this would not be
 easy to implement so the idea was dropped.

- Publication Review- Denise Lott was introduced. She is working with Sandy Casale.
 Denise submitted 4 items to Heide and Pam to be used in SITL. None of them appeared. She was informed that the staff member to approach in the future is Sherry who puts the information on line for SITL.
 - **(A)** Rick suggested she meet with Sherry to discuss the process of getting IOTC articles published.

Rick and Mary Kenny will purchase the food trays. Joe Lombardi (Mary's brother) has agreed to act as the DJ for no charge. Set-up crew will be there at 5:30 (Kennys, Boltons, Swansons, Susan and Judy). Note: The usual \$100 deposit fee was waived, largely because of the current disarray of the HOA F&B department. We still need to make the bar bill and do the clean up after the event.

 setting up something for January.
