## IOTC BOARD MEETING - MONDAY, MAY 2, 2022 - FITNESS CENTER

Meeting was called to order at 1 pm. Quorum was present

Attending: Richard Eslick, Molly Bergesen, Bernie Emery, Carole Rockland, Viv Guimond and Norb Guimond.

Minutes from the April 4<sup>th</sup> meeting were approved.

**OLD BUSINESS:** Richard reported that C.J. Berry is still deciding about whether to serve as IOTC president. Because of some personal issues and C.J.'s Dad recent death, Richard and Molly will meet with him later in May.

There is still a question about \$500 that Blue Star donated to the Jason Morton Tournament. Bernie and Richard will follow up.

**NEW BUSINESS** - Molly brought up the idea of a mixer with the Pickleball Club. Idea is to have tennis players play PB with PB players and PB players play tennis with tennis players. Looking at a date of November 5. Suggestions are to keep participation limited to see how this works (extra PB paddles/extra tennis rackets etc.). Right now they have 8 people who have shown interest. Molly will put out something as a EBLAST and perhaps put something in SITL.

Molly presented the use figures on the Ironwood courts from January 1 thru March 31. There was probably an average of 75% usage M-W-F. With these statistics in mind, Molly has requested through Jeff that IOTC is again granted permission to use these courts during high seasons (October 17, 2022 thru April 14, 2023).

Carole Rockland provided a list of IOTC members who are willing to volunteer to help with IOTC events. We will be using this list (and hopefully, adding to it). At our last social, members made suggestions on events, etc. for our club; they included: more socials/mixers, night play; group event to Indian Wells, etc.

**MEMBERSHIP REPORT:** Carole Rockland reported on IOTC membership numbers. April's number was 276 and we have added members for a total of 283.

**TREASURER'S REPORT:** As of April 30, balance in IOTC's account is \$4,283.23. Only outstanding bills not yet paid are for 3 cases of tennis balls purchased by Molly for a cost \$147.00
