

IronOaksTennis Club (IOTC) Board Meeting Minutes: October 14, 2013 2:30PM - Ocotillo Room

PRESIDENT - Rick Kenny

Racquet Committee Report:

Rick expressed regret that the HOA Bd. largely ignored the hard work of this advisory group. He mentioned that there would be a Racquet Committee vote at the next meeting to either have this committee: a. become part of the Fitness Committee, b. become a standing ad hoc committee OR c. disband.

Review of the updated IOTC Annual Operating Plan:

Due to the greatly reduced income from the past Clay Court Slam, Rick had made plan adjustments re: expected income and the need to monitor costs. We now anticipate an end of the Board year budget loss.

Suggestions were solicited to help build income for the club. Judy suggested club members pay annual dues, i.e. \$10. Dick recommended sponsors for our tournaments, i.e. relators, to off set costs.

(A)Board members were asked to send their ideas to Rick and he will consolidate them and make a proposal at the next meeting.

Review of Rick's meeting with Heide:

- The HOA Board has made it clear that there must be a division between Heide as an employee of the HOA and our needs/expectations as a social club. The IronOaks Rules for Tennis and Pickleball 2013 makes no reference to social clubs. Players that pay a HOA fee for tennis are considered "Tennis Members"
- The IOTC Recognition Awards that award early court reservations, are still valid and the process will remain intact. Heide will make special entries.
- The upcoming Change of Use issue and possible conversion of the clay courts to hard surface was discussed. The IOTC rejects any court conversion.
- Note: Pam Barber, Director of Fitness and Racquet Sports, now reports facility issues to the GM and Heide deals with play issues. This was clarified by Clark Champion at the last Racquet Committee meeting.
- An issue to resolve is whether IOTC or the HOA hosts USTA events. Heide and Rick will get clarification from the HOA.
- Heide will be blocking out time slots for "organized" play (Team Tennis, VOS, etc.). The proposal is that any "group" that needs 3 or more courts (6 max.) and has a published seasonal schedule can qualify as a group have courts blocked for them.
