PRESIDENT – Judy Gahide

Judy introduced member Linda Snider who presented concerns of the membership to the board.

Linda reported that wind flags have been installed using tennis fund monies which pam facilitated.

- Linda feels the HOA is making policy changes without consulting/ involving the IOTC.
- Another issue is the landscapers working in the immediate area during primetime which is not only a serious noise nuisance but a health issue with the dust, spraying of chemicals, etc.. She has spoken to Pam and Ron Kotnik about this as well as brought it before the HOA board to no avail. Mickey recommended comment cards be sent to the board.
- Linda was told by Pam that guest passes were no longer being issued as there was no way to track them. She was told, incorrectly, that there is \$10 Guest fee even after prime time. It seems those working at the desk are unaware of the guidelines. Randi said the rules should be clarified to avoid confusion.
 - (A) Judy will discuss this with both Pam and Josh.
- Court time vs Ball Machine usage- there is a conflict / overlap of reserve time. These need to be coordinated. Dick said Josh agreed to do this (via the Chelsea system) but it has not yet happened.
- Linda asked how often the website was updated and mentioned that tournaments were not listed. Dick explained he posts what he receives and that he is not getting the info from Josh.
